Deep Tech Central (DTC) Blind Box Campaign

Terms and Conditions

By participating in the “*DTC Blind Box Campaign*” (the “**Campaign**”), participants acknowledge that they have read, understood, and agree to be bound by these Terms and Conditions, including the Personal Data provisions set out herein.

1. Organiser

The Campaign is organised by **Singapore Innovate Pte Ltd. (SGInnovate)** (the “**Organiser**”).

2. Territory

The Campaign is open only to participants in **Singapore**.

3. Campaign Period

The Campaign will run from **8 April 2026, 12:00 hours (SGT) to 30 June 2026, 23:59 hours (SGT)** (the “**Campaign Period**”). The Organiser reserves the right to amend, extend, suspend, or terminate the Campaign Period or any part thereof at its sole discretion without prior notice.

All times stated are Singapore Time (UTC +08:00).

4. Eligibility

Participation in the Campaign is open to individuals who meet **all** of the following criteria (the “**Eligible Participants**”):

- Singapore Citizens or Permanent Residents;
- Aged **18 years or above** at the time of participation; and
- Successfully new DTC account sign-ups or existing DTC account holders during the Campaign Period.

The following individuals are **not eligible** to participate:

- Employees, officers, and representatives of the Organiser, its parent companies, subsidiaries, and affiliates; and
- Immediate family members (parent, spouse, sibling, or child, and their respective spouses) or household members of the above.

5. Campaign Structure

The Campaign consists of **two components**:

- 1. Physical Event Giveaway (Launch & Outreach Events)**
- 2. Online Campaign**

Eligible Participants may take part in one or both components, subject to meeting the applicable mechanics.

6. Campaign Mechanics

6.1 Physical Event Giveaway (Sure-Win)

Eligible Participants who attend any official launch or outreach event during the Campaign Period (including but not limited to events held at Fusionopolis, Geneo, and Punggol Digital District) may participate in a *Sure-Win Lucky Draw* during the event’s manned operating hours.

To qualify, participants must:

- Sign up or log on to a free DTC account; and
- Complete their talent profile, including **Education, Skills, and CV upload**.

Upon on-site verification, participants will be entitled to **one (1) draw** from the physical lucky draw pool per event.

Each participant may win **only one (1) prize per event**.

Prizes are distributed on-site unless otherwise stated.

Prizes available at each Event include but not limited to:

1. One (1) full set of DTC blind boxes
2. Individual blind boxes
3. DTC stickers
4. DTC pencils

6.2 Online Campaign

The Online Campaign is open throughout the Campaign Period.

Mechanics:

- **Early Bird Prize**
The **first 100 participants** who sign up for a new DTC account and complete their full DTC profile (Education, Skills, and CV upload) will each receive **one (1) full set of DTC blind boxes**.
- **Lucky Draw Entry**
Subsequent Eligible Participants who complete at least one profile section (Education, Skills, or CV upload) will receive **one (1) entry** into the Online Lucky Draw to win **one (1) Blind Box**.
- **Referral Bonus**
Participants may earn additional lucky draw chances by referring friends. Each successful referral (where the referred individual signs up and completes their DTC profile) grants the referrer **one (1) additional entry**.
There is no limit to the number of referrals.

Each participant is limited to **one (1) prize** under the Online Campaign.

7. Prizes

Prizes include, but are not limited to:

- **Full Set** – Complete DTC Blind Box collection
- **Individual Blind Box** – One random blind box
- **Merchandise** – Stickers or plantable pencils

All prizes are:

- Awarded on a **while-stocks-last** basis
- **Non-transferable, non-exchangeable, and non-redeemable for cash**

The Organiser reserves the right to substitute any prize with another of equivalent value without prior notice.

8. Winner Notification & Prize Collection

- **Physical Event Winners:**
Prizes will be distributed on-site where applicable.
- **Online Campaign Winners:**
Winners will be notified via the email address registered with their DTC account by **31 July 2026** or within **fourteen (14) working days** after the relevant draw date.

Prizes must be collected in person at the **SGInnovate Office** (address to be provided via email notification).

Participants must present:

- The notification email; and
- A valid NRIC or FIN for verification.

Prizes not collected within **one (1) month** from the notification date will be forfeited.

If a winner fails to respond within the stipulated timeframe, the Organiser reserves the right to select an alternative winner.

9. Personal Data Protection

By participating in the Campaign, participants consent to the collection, use, and disclosure of their personal data (including but not limited to name, contact details, CV, education history, skills, images, audio, and audiovisual recordings) for the following purposes:

- Administration of the Campaign and prize fulfillment;
- Verification of eligibility and identity;
- Recruitment, talent matching, and platform services provided by Deep Tech Central;
- Marketing, publicity, and promotional communications related to SGInnovate and Deep Tech Central; and
- Any other purposes directly related to the Campaign.

3. The Organiser shall not be liable for any loss, damage, injury, tax liability, or expense arising from participation in the Campaign or use of any prize.
4. The Organiser may disqualify any participant who tampers with the entry process or acts in violation of these Terms and Conditions.
5. The Campaign may be suspended, modified, or terminated due to technical issues, force majeure, or other circumstances beyond the Organiser's control.
6. Participants agree to indemnify the Organiser against all claims arising from their breach of these Terms and Conditions.

11. Governing Law

These Terms and Conditions are governed by and construed in accordance with the **laws of Singapore.**
